CALL TO ORDER

The Canvassing Board meeting was called to order by Judge Daniel Kanner at 1:00 p.m.

Motion to approve last Canvassing Board meeting minutes was granted by Canvassing Board members.

BOARD TO CONSIDER CERTAIN ADDITIONAL VOTE-BY-MAIL BALLOTS, AS NEEDED

Mary Hall went over the different types of ballots that the Canvassing Board members will be reviewing today. 8,352 Vote-by-Mail (VBM) ballots were received as of yesterday during the VBM drop off process at the early voting sites. 20,862 voters voted early as of 8/13. Vote-by-Mail ballots to be reviewed were stored in a bin with seal #s 0103424 and 0103496.

- 46 Voter certificates received without ballot inside.
- 7 Vote-by-Mail ballots returned by voters who are deceased.
- 1 Voter returned the voter certificate signed and ballot inside was torn into pieces. Motion to reject ballot was approved by Canvassing Board members.
- 1 UOCAVA voter returned ballot but cannot be identified since ballot was returned without the voter certificate. Motion to reject ballot was approved by Canvassing Board members.
- 49 Vote-by-Mail ballots without signature with completed cure affidavit. Motion to accept all ballots was approved by Canvassing Board members.
- 1 UOCAVA voter was asked to provide a clear ballot to our office which he did. Motion to accept ballot.

 85 UOCAVA ballots already duplicated were presented to the Canvassing Board for review. Ballots were accurately duplicated. Motion to approve 85 UOCAVA ballots was granted by Canvassing Board members.

386 Vote-by-Mail ballots (48 Reps, 297 Dems, 41 NPAs) were duplicated and presented to the Canvassing Board members for review. Voter intent ballots were reviewed as well by the Canvassing Board members and a motion was done on every voter intent ballot.

Mary Hall asked for permission to tabulate the duplicated Vote-by-Mail ballots. Motion to tabulate duplicated ballots was approved by Canvassing Board members.
