## WHO IS ELIGIBLE TO VOTE

- State Senate, District 33 Special Election Only voters who are registered in the district will be able to vote in this race.
- Municipal Elections Only voters who are registered in Hillsboro Beach, Pembroke Pines (Seat 1 & 4), Lauderdale-by-the-Sea and Lighthouse Point will be voting.
