## PRESIDENTIAL PREFERENCE PRIMARY & MUNICIPAL ELECTIONS - MARCH 19, 2024

### WHO IS ELIGIBLE TO VOTE

Only voters registered as Republicans across the county and voters residing in Hillsboro Beach, Lauderdale-by-the-Sea, Pembroke Pines, and Sea Ranch Lakes will be eligible to participate in the March 19, 2024 Election. *Voters registered as Democrats, No Party Affiliation, or any Minor Political Party living outside of these four cities will NOT have candidates or referendums to vote for on March 19th.*
