#### BOARD TO CONSIDER CERTAIN ADDITIONAL VOTE-BY-MAIL BALLOTS, AS NEEDED

There are 208 duplicated ballots (28 Rep, 155 Dem and 25 NPA) to be reviewed today. There are 90 UOCAVA ballots that were duplicated and need to be reviewed today. Today will be reviewing of duplicated vote-by-mail ballots and election night results at 7:00 p.m. UOCAVA ballots were stored in a bin with seal # 0604329 and 1186937. Mary Hall asked permission to duplicate 9 UOVOCA ballots that had arrived today. Motion to authorize UOCAVA ballots to be duplicated was granted by Canvassing Board members.
