#### **CALL TO ORDER**

The Canvassing Board meeting was called to order by Judge Kenneth Gottlieb at 1:00 p.m.

Motion to approve minutes from last Canvassing Board meeting was granted by Canvassing Board members.

#### **BOARD TO CONSIDER VOTE-BY-MAIL**

Chief Mary Hall briefed Canvassing Board members on Vote-by-Mail ballots. About 550,000 Vote-by-Mail ballots were mailed and 93,000 Vote-by-Mail ballots were received. 11,000 Vote-by-Mail ballots were received today. This information is available on the Supervisor of Elections' website daily.

About 726 duplicated UOCAVA ballots have been reviewed by the Canvassing Board members. Ballots already reviewed by Judge Gottlieb were stored in a bin with seal #1699982 and 1723060. Motion for ballots to be turned to the Elections staff for processing and tabulation was approved by Canvassing Board members.

Canvassing Board members reviewed 11 duplicated Vote-by-Mail ballots. The board looked at the voter intent and accuracy of the duplication.

22 UOCAVA ballots were stored in a bin with seal #0601969 and 0601968. Canvassing Board members reviewed ballots for accuracy of the duplication and voter intent.

Vote-by-Mail ballots stored in a bin with seal # 0754743 and 0754711. Motion to duplicate ballots already reviewed by the Canvassing Board members was approved by Canvassing Board members.

Motion to accept duplicated ballots already reviewed by Canvassing Board members to be turned to staff for tabulation was approved by Canvassing Board members.

NOVUS Duplication –Vote-by-Mail ballots duplicated by using the NOVUS systems were presented to the Canvassing Board by categories for review.
