The next Canvassing Board meeting will be in the tabulation room to allow space for the 65 machines that are needed for the Logic and Accuracy testing and to accommodate the public. There is no legal impediment for the Canvassing Board members to observe the Logic & Accuracy Testing through the glass.

CONSIDER PROCEDURES REGARDING THE CONDUCT OF BOARD MEETINGS INCLUDING PUBLIC PARTICIPATION

In light of the pandemic, guidelines were prepared by counsel. Nathaniel Klitsberg went over the guidelines and procedures. Members of the public will be able to participate through ZOOM
