CALL TO ORDER

The Canvassing Board meeting was called to order by Judge Daniel Kanner at 1:00 p.m.

Motion to approve last Canvassing Board meeting minutes was granted by Canvassing Board members.

BOARD TO CONSIDER CERTAIN ADDITIONAL VOTE-BY-MAIL BALLOTS, AS NEEDED

1,609 duplicated ballots (264 Reps, 1148 Dems, 197 NPAs) were completed so far. There are 284 duplicated ballots to be reviewed today. 206 UOCAVA ballots were completed so far and 46 UOCAVA ballots will be reviewed today.

Mary Hall informed Canvassing Board members that 18,149 vote-by-mail ballots were dropped off at early voting sites during the early voting cycle. 40,124 voters voted early. There are 17 signature-differ and 294 no-signature vote-by-mail ballots. Staff contacted voters last week and will be contacting them again today about completing and submitting a cure affidavit. Vote-by-Mail ballots cannot be dropped off at the precinct on election day.

UOCAVA ballots were stored in a bin with seal #s 0665289 and 0666492.

 There are 46 UOCAVA ballots duplicated and presented to Canvassing Board members for review. Voter intent ballots reviewed. Motion to accept 46 UOCAVA ballots was approved by Canvassing Board members.

- 60 Vote-by-mail ballots signed by other than voter. Motion to reject ballots signed by other than voter was approved by canvassing Board members.
- 1 Voter signed voter certificate and wrote on ballot that had moved. Motion to reject ballot was approved by Canvassing Board members.
- 2 Voter certificates had no ballot enclosed. Motion to reject voter certificates was approved by Canvassing Board members.
- Wife and husband of different parties. Husband voted wife's vote-by-mail ballot and mailed it back. Wife went to vote in person during early voting. Motion to reject returned vote-by-mail ballot was approved by Canvassing Board members.

284 duplicated ballots (234 Dems, 18 NPA and 32 Reps) were presented to Canvassing Board members for review. Voter intent ballots reviewed. Motion to accept duplicated ballots reviewed this afternoon was approved by Canvassing Board members.
