#### CALL TO ORDER

The Canvassing Board meeting was called to order by Judge Nina Di Pietro at 3:00 p.m.

Motion to approve minutes from last Canvassing Board meeting was granted by Canvassing Board members.

Chief Deputy Mary Hall presented Vote-by-Mail (VBM) ballots to the Canvassing Board members for their review.

(91) Overvote Vote-by-Mail (VBM) ballots presented to the Canvassing Board members. Motion to approve that 88 are overvotes was granted by the Canvassing Board members. 3 VBM ballots placed aside for voter intent review. (1) VBM ballot was determined to be an overvote, (2) VBM ballots determined to be voter intent.

(24) Undervote VBM ballots presented for review. Motion that they are all undervote VBM ballots was granted by the Canvassing Board members.

(28) Voter Intent VBM ballots to be reviewed by the Canvassing Board members. Canvassing Board voted on each ballot. (4) of the Voter Intent VBM ballots were determined to be overvotes.

(27) Duplicated VBM ballots presented for review to the Canvassing Board members. Duplicate numbers: 010095, 010084, 010083, 010096, 010094, 010093, 010092, 010091, 010090, 010089, 010088, 010087, 010086, 010085, 010082, 010081, 010080, 010079, 010078, 010077, 010076, 010097, DUP 106071, 010072, 010073, 010074, 010075. Motion that all duplicated ballots are in good order was granted by the Canvassing Board members. Motion to approve (1) VBM ballot with Duplicate # in question was granted by the Canvassing Board members. Duplicate number 106071 was added to the duplicated ballot.

(11) Vote-by-Mail ballots with Cure Affidavits (stored in an orange bag with seal# 0725194) were presented to the Canvassing Board members for review. Motion to approve all Cure Affidavits was granted by the Canvassing Board members.

Ballots reviewed today by the Canvassing Board members will be available for Public Inspection tomorrow, and ballots needed to be duplicated will be presented at the next Canvassing Board meeting.
