CALL TO ORDER

The Canvassing Board meeting was called to order by Supervisor of Elections Joe Scott at 6:00 p.m. Motion to recess for 20 minutes was granted by present Canvassing Board members.

6:40 p.m. - Motion to approve minutes from last Canvassing Board meeting was granted by Canvassing Board members.

Chief Deputy Mary Hall presented Vote-by-Mail (VBM) ballots to the Canvassing Board members for their review.

- (6) Voter Intent VBM ballots were reviewed by the Canvassing Board members. Motion to allow duplication of ballots was granted by the Canvassing Board members.
- (3) Sets of Duplicated VBM ballots presented for review. Duplicate #s 010152, 010151 and 010150. Motion that ballots were accurately duplicated was granted by the Canvassing Board members.
- (9) Overvote VBM ballots presented to Canvassing Board members for review. Motion that one ballot is a vote for Roselind Osgood passed by 2 out of 3 Canvassing Board members votes. Motion that 8 ballots are overvotes was granted by the Canvassing Board members.

- (3) Undervote VBM ballots presented for review. Motion that ballots are undervotes was granted by the Canvassing Board members.
- (1) Vote-by-Mail ballot with Cure Affidavit (seal# 0603802) was reviewed. Motion that it is a valid Cure Affidavit was granted by the Canvassing Board members.
- (1) Voter Precinct Not Voting presented for review. Motion to hold on ballot until further guidance from the Division of Elections.

During the last Canvassing Board meeting a voter told the Canvassing Board members that she received a Vote-by-Mail ballots; however, she never requested one. After further research, the office found evidence that the voter requested a Vote-by-Mail ballot and had previously voted by mail. Voter was mailed findings corroborating that the ballot that she received was requested by voter.

- (7) Voter Intent VBM ballots previously reviewed were duplicated and presented to Canvassing Board members for review. Duplicate #010157, 010158, 010159, 010160, 010161, 010162, 010163. Motion that ballots were accurately duplicated was granted by the Canvassing Board members.
- (4) Duplicated Undervote and Overvote VBM ballots that were previously reviewed and were out for Public Inspection. Duplicate #s 010155, 010154, 010153, 010156. Motion that all ballots were duplicated accurately was granted by the Canvassing Board members.
