**MEETING CONVENED: 2:00 P.M.**

**Agenda Item #1:** Meeting was called to order by Judge Ginger Lerner-Wren at 2 p.m. Introduction of Canvassing Board members and legal counsels.

**Agenda Item #2:** Motion to approve the minutes from the Canvassing Board meeting that was held on July 19<sup>th</sup> was granted unanimously by Canvassing Board members.

**Agenda Item #3:** Chief Deputy Mary Hall presented to the Canvassing Board members Vote-by-Mail (VBM) ballots with any irregularities. She explained that Public Inspection is being conducted from 8:30 a.m. to 9:00 p.m. daily. During Public Inspection period there were 14 VBM ballots that were challenged because of signature. The Voter Certificate and Voting Maintenance form with a copy of current signature for each of the challenged voter's VBM ballots were presented to Canvassing Board members for their review.

Motion considered and granted by Canvassing Board members to approve (8) Vote-by-Mail ballots with signature challenge. Voters' name: Steal, Ortiz, Kukulka, Peter Salvator, Sakina, Pearson, Krimi, Golphin.

(6) Vote-by-Mail ballots with signature challenge were not approved by the Canvassing Board members and voters will be given the opportunity to cure ballot. Voters' name: Wasserstrom, Rito, Fine, Miller, Wrilley, Lundin.

(2) Vote-by-Mail ballots returned from voters with last name Singer were challenged because signature irregularity. Each of the Voter Certificate has 2 signatures – husband and wife signed each other's ballots. Motion to approve ballot was granted by Canvassing Board members.

(5) Vote-by-Mail ballots challenged due to National Change of Address (NCOA). Motion to dismiss challenges was granted by the Canvassing Board members.

(1) VBM ballot was out for Public Inspection review, opened and processed by the time the challenge was received. Motion to dismiss challenge was granted by the Canvassing Board members.

Motion to open and process the VBM ballots that were approved by Canvassing Board members.

(104) UOCAVA ballots received via fax and duplicated were presented to Canvassing Board members for review.

(16) Undervote/blank ballots presented to Canvassing Board member for review. Motion that all ballots are undervotes was granted by Canvassing Board members.
