MEETING CONVENED: 12:00 P.M.

Meeting was called to order by Judge Florence Taylor Barner at 12:00 p.m. Participating at this time was Judge Florence Taylor Barner, Supervisor of Elections Joe Scott, and Broward Mayor Michael Udine. Motion to approve minutes from the preceding Canvassing Board meeting was granted by the board.

Chief Deputy Mary Hall will be presenting to the Canvassing Board members the different categories of Vote-by-Mail (VBM) ballots to be reviewed today.

(559) Voter Intent VBM Ballots – presented to Canvassing Board members for their review and determination. Board reviewed and gave a motion on every Voter Intent VBM ballots.

5 minutes recess – Canvassing Board members reconvened at 2:05 p.m. and continued with the reviewing of Voter Intent VBM ballots. Motion to duplicate ballots as voted on by the board, have them available for Public Inspection and be tabulated was granted by the Canvassing Board members.

- (93) Possible Voter Intent VBM Ballots these are VBM ballots that SOE staff members have determined are ambiguous and need to be reviewed by Canvassing Board members for determination of any voter intent. These ballots will be available for Public Inspection, and then tabulated. Canvassing Board members reviewed ballots and put aside any ballot that needs to be reviewed for voter intent. Board voted on each ballot. Motion to duplicate ballots, have them available for Public Inspection and to tabulate was granted by Canvassing Board members.
- (61) Sets of Duplicated VBM Ballots after reviewing ballots, the Canvassing Board granted a motion that all ballots were duplicated properly.
- (164) Overvote VBM Ballots motion to approve that ballots are overvotes was granted by the Canvassing Board members.
- (110) Military and Overseas VBM Ballots (86 ballots duplicated by system and 24 ballots manually duplicated) –motion that Military and Overseas ballots were duplicated properly was granted by the Canvassing Board members.
- (1) VBM ballot returned by voter without voter certificate. Motion to reject ballot was granted by the Canvassing Board members.
- (6) VBM Ballots with Cure Affidavits Canvassing Board members gave a motion on each ballot that they were properly cured.
- (3) VBM ballots protested during Public Inspection by observers presented to Canvassing Board members for review.
