MEETING CONVENED: 1:00 P.M.

Meeting was called to order by Judge Florence Taylor Barner at 1:00 p.m. Participating at this time was Judge Florence Taylor Barner, Supervisor of Elections Joe Scott, and Broward Mayor Michael Udine. Motion to approve minutes from the preceding Canvassing Board Meeting was granted by the board.

Chief Deputy Mary Hall will be presenting to the Canvassing Board members the different categories of Vote-by-Mail (VBM) ballots to be reviewed today.

(462) Voter Intent VBM ballots – presented to Canvassing Board members for their review and determination. Board reviewed and gave a motion on every Voter Intent VBM Ballots.

Motion for Voter Intent ballots to be duplicated, placed for Public Inspection and tabulated was granted by the Canvassing Board members.

- (37) Duplicated VBM ballots reviewed by the Canvassing Board members.
- (48) Overvote VBM ballots reviewed by the Canvassing Board members.

- (1) Voter Intent VBM ballot reviewed, and motion given by the board.
- (25) VBM ballots with Cure Affidavits presented to the Canvassing Board members for their review. Motion to approve the VBM Ballots with Cure Affidavits from precincts: V019. M008, F004, C020, C018, W018, V022, F001, N004, E009, Q061, P001, M009, R018, Q043, D008, M014, F003, A002, R009, X005, J010, V002, D006, Q040 was granted by the Canvassing Board members.
- (7) VBM ballots received from deceased voters. Motion to approve (1) VBM ballot from a deceased voter was granted by the board because voter died after the VBM ballot was signed. Motion to reject (6) VBM ballots from deceased voters was granted by the board.
- (2) Objections to signatures mismatch presented previously to Canvassing Board members was brought to the board again for their review. Husband and wife signed each other ballots. Motion to approved both VBM ballots was granted by the Canvassing Board members.
- (1) VBM ballot that was protested during Public Inspection and presented to Canvassing Board for review. Canvassing Board member requested for election staff to investigate further. VBM ballot was signed by someone else, and voter will be going to vote in person. Motion to reject VBM ballot was granted by Canvassing Board members.
- (3) VBM ballots protested because signature doesn't match during Public Inspection by observers are presented to Canvassing Board members for review.

- (4) VBM ballots received from voters that already voted early. Motion to reject VBM ballots was granted by the Canvassing Board members. Discussion about turning in VBM ballots mailed after the date that the voter voted early to State Attorney's Office or FDLE. Nothing in the Florida law that mandates that it is a function of the Canvassing Board members.
- (4) Voter Intent ballots that were already scanned (additional Voter Intent ballots) presented for review. Motion on each ballot was done by Canvassing Board members.
- (18) VBM ballots received from voters that moved away. Motion to approve (3) VBM ballots and to notify county that voters voted in Broward was granted by the Canvassing Board members. Motion on each of the remaining VBM ballots to reject, release and notify voters that their ballot was rejected was granted by the Canvassing Board members.
