MEETING CONVENED: 10:00 A.M.

The meeting was called to order by Judge Betsy Benson at 10:00 a.m. In attendance were Judge Betsy Benson, County Commissioner Lamar P. Fisher and Supervisor of Elections, Joe Scott.

Pledge of allegiance

Chief Deputy Mary Hall welcomed the Canvassing Board members and the audience to the meeting and proceeded to outline the Logic and Accuracy (L&A) Testing process from the provided script. The following election equipment was scheduled for testing: (45) Election Day DS200s, (5) Early Voting DS200s, (12) DS850s, (2) Express Votes, and (16) Fujitsu FI-7900 scanners.

The board authorized the Public Logic & Accuracy Test and approved the Authorization for Public Testing to begin. A motion was approved by the board members to authorize the processing of Vote-by-Mail ballots, including opening, tabulating, and duplicating them, subject to the completion of the L&A Test and public inspection. This process is set to begin no sooner than October 10th.

Zero tapes were presented to the Canvassing Board members for review to ensure that all machines had been zeroed out before testing. The board reviewed the zero tapes, and the audience was given the opportunity to review the tapes from the DS200s as well. The Supervisor of Elections (SOE) staff members were then authorized to begin feeding the test

ballots into the machines. No updates to the machines will be made after the L&A test, and the office confirmed that no software changes will be implemented for this election. The staff was authorized to proceed with the L&A testing.

While the testing was in progress, the board reviewed pending agenda items, including the “Guidelines and Procedures for the Conduct of Board Meetings, Observer and Public Participation at Meetings.” A representative from the Republican Party requested an update to bullet point #4, proposing a change from “challenge/object” to “challenge/protest.” The board agreed to this update, and the Guidelines and Procedures will be reposted on the website. There was also a review of the Vote-by-Mail (VBM) certificate signature process during public inspection, with all signatures on file being made available. A representative from the Republican Party requested that the public inspection procedure from the last Primary Election be reinstated, and this matter will be discussed at the next Canvassing Board meeting. Additionally, legal counsel will be changing the word from “object” to “protest” on bullet # 4 from the “Guidelines and Procedures”. With that change being made, the board members granted a motion to approve the “Guidelines and Procedures.”

A PowerPoint presentation on the Standards for Voter Intent Questions was delivered by Canvassing Board legal counsel, Scott Andron, in collaboration with Devona Reynolds Perez, SOE legal counsel.

A motion was granted to approve the supplemental Canvassing Board schedule, with the following meeting dates set for 2:00 p.m. unless otherwise noted:

- Tuesday, October 15, 2024
- Thursday, October 17, 2024 (10:00 a.m.)
- Tuesday, October 22, 2024
- Thursday, October 24, 2024
- Tuesday, October 29, 2024
- Thursday, October 31, 2024
- Friday, November 1, 2024

Commissioner Udine will attend the meeting on October 17th on behalf of Commissioner Lamar Fisher, with that meeting starting at 10:00 a.m.

Total tapes were presented to the Canvassing Board for review. The results from the L&A test were compared with the predetermined results provided to the board, and the Canvassing Board confirmed that the results matched the script. The next step was to zero out and seal the tabulation machines.

A motion to recess was granted at 12:10 p.m. for 45 minutes.

When the meeting resumed at 12:56 p.m., the SOE staff presented the results from the Clear Ballot machines for board review and approval. The tabulation equipment was zeroed out, and zero tapes were presented to the board for verification. Staff was authorized to proceed with shutting down and sealing the equipment. The board granted a motion to approve the testing of the Clear Ballot system, and they signed the Clear Ballot System Testing and Tabulation System Summary Report. After reviewing the zero tapes, the board confirmed that all tabulation machines had been properly zeroed.

A motion to approve the zero tapes and the results of the L&A testing was granted by the board. The Clear Audit zero reports were also presented and approved by the Canvassing Board. All materials from the L&A testing will be stored in a clear bin and sealed as required

by Florida statute. The Canvassing Board members signed the Logic and Accuracy Testing labels, using the following seal numbers to secure the bins: 0851181, 0851182, 0851183, 0851184, 0851185, 0851186, 0851189, 0851190, 0851187, and 0851188.
