**MEETING CONVENED: 10:00 A.M.**

The meeting was called to order by Judge Jennifer Hilal at 10:00 a.m. In attendance were Judge Jennifer Hilal, County Vice Mayor Robert McKinzie, and Supervisor of Elections Joe Scott.

#### **Pledge of Allegiance**

Chief Deputy Mary Hall welcomed the Canvassing Board members and requested permission to commence the Logic and Accuracy (L&A) Testing. Permission was granted by the Board. Kevron Aird stated that the following equipment would be tested: ten (10) Election Day DS200s, six (6) DS850s, two (2) ExpressVote machines, and eight (8) Fujitsu FI-7900 scanners. He also informed the Board that a testing script had been provided for the L&A Testing. The Board reviewed the zero tapes and confirmed that all machines were zeroed out.

Approval of Guidelines and Procedures for Observers and Meetings - A motion to approve the Guidelines and Procedures for Observers and Meetings was made and unanimously approved by the Canvassing Board members.

Authorization to Begin Public Inspection and Vote-by-Mail Processing - Authorization was requested to begin public inspection, including the processing, opening, tabulation, and duplication of Vote-by-Mail ballots. A motion to begin was made and unanimously approved by the Board.

Separate training regarding voter intent will be provided to Vice Mayor McKinzie. The other two Board members have previously received training, and no changes have been made since their training.

The Board recessed for fifteen (15) minutes.

L&A Test Results - Upon reconvening, Kevron Aird presented the equipment results, which matched the expected results outlined in the testing script. The Clear Ballot audit system result sheet was also provided to the Board for review and confirmed to match the testing script.

A motion confirming that the test deck ballots were scanned properly, that all results reviewed matched the script, and that the L&A Testing was a success was made and unanimously approved by the Board. A motion to zero out the machines and reprint tape showing machines were zero out and prepare them for the election was unanimously approved.

Public Comment - Herman Schnell of the Republican Party brought to the Board's attention some numbers he identified on the Clear Ballot results. Staff provided an explanation, confirming that the Clear Ballot results sheet was correct.

Elizabeth Burns, a candidate for Fort Lauderdale District 4, inquired about a March 10 Municipal Election advertisement that was not conducted by the Supervisor of Elections. Ms. Burns' concern was acknowledged and was advised to direct her concerns to the Fort Lauderdale City Commission.

Final Zero Report and Sealing - Zero tapes for the Clear Ballot system, DS200s, and DS850s were provided, reflecting that all machines were zeroed out and ready for the election. A motion confirming that all machines were zeroed out and authorizing them to be sealed was made and unanimously approved by the Board.

The Logic and Accuracy Test materials were placed in a clear container and sealed with seal numbers 5066223 and 5066224.

The Board members approved a motion to hold the next Canvassing Board meeting on Tuesday, March 10, 2026, at 4:00 p.m., to continue until conclusion.
